

## Accessibility statement 01/01/2024

The desert and sea R&D company is a regional research and development center.

In this statement we aim to optimize the use and improve our service in regards to accessibility and equal rights for people with disabilities.

This website meets the requirements of the Equal Rights for Persons with Disabilities (Service Accessibility Adjustments), 2013.

The accessibility adjustments were made according to the recommendations of the Israeli standard (TI 5568) for content accessibility on the Internet at the AA level and the international WCAG2.0 document.

The tests were tested for the highest compatibility for Firefox and Internet Explorer browsers.

The site provides a semantic structure for assistive technologies and support for the accepted usage pattern for operating with a keyboard using the arrow keys, Enter and Esc to exit menus and windows.

Optimized for display in common browsers and for use on the cell phone.

Accessibility measures available on the site:

- Support for all standard browsers (such as Chrome, Explorer, FireFox, Opera, Mozilla).
- The site's contents were written in clear language and legible fonts were used
- Site structures are made up of headings, paragraphs and lists
- Navigating the site is simple and convenient and includes available and clear menus
- The links on the site are clear and explain where they are taken after clicking on them
- Links at the beginning of the page that allow skipping to the content
- Textual description for images and icons for assistive technologies
- Adapting the site to working environments with different resolutions (responsive)
- Stop and play buttons for video galleries
- ARIA rules have been implemented that help to interpret the website content in a more accurate and better way
- Accessibility of menus, forms and fields, title hierarchy, tab components, pop-up windows and more

## Changing the display on the website

- You can increase or decrease the view of the site by pressing one of the "CTRL" buttons together with the mouse wheel or together with the "+" sign for enlargement or together with the "-" sign for reducing the display. Each click will decrease or increase the screen by ten percent (10%)
- Changing the font size will be done using the accessibility menu on the website
- Surfers who do not have a mouse or who cannot use a mouse can activate the features found on the site by pressing the "TAB" key. Each click will move the cursor to the next option on the site

Pressing the "Enter" key will activate the link on which the cursor is located

- The site does not include flickering, flickering and moving content. In places where such contents are found, you can stop them by standing on them and clicking the mouse or go over them by pressing the "TAB" key and pressing the "Enter" key

Site adaptation for the visually and hearing impaired

- Basic visibility (resolution) increasers
- Voice recognition software
- Voice recognition packages of the operating systems

## Accessibility restrictions

The website management does everything possible to make sure that all the displayed pages are accessible.
